LEGISLATIVE REPORT

The reform majority of the STRS Board failed to pass the Performance-Based Bonus Incentive Program at the June Board Meeting. There were several claims that the Investment Staff would resign if they did not receive a bonus, Therefore, at the July special meeting the STRS Board approved an amended version of the bonus payment for investment staff. It includes potential reductions to the incentive payments for senior investment staff depending on certain metrics.

There is conflicting information and turmoil regarding our pension fund. To be absolutely clear, ORTA has not advocated for any investment company but has advocated for investigation of index-based strategies that show promise to achieve better returns. Because our system spends more on benefits than it takes in each year, making the best investment return possible at the lowest cost is essential.

The next STRS Board Meeting is August 20 & 21, 2024. I will report any new information at our September 18th luncheon. I hope to see you there. Bernie Machovina–Legislative Chair
